CHAS—The Way Forward

As you know, the Catholic Health Association of Saskatchewan lost its provincial grant in October 2016, a loss which represented a full third of our annual revenue. Since that time, we have undertaken a facilitated change management process with our key stakeholders, and at the end of June, the Board approved motions to reflect our new fiscal reality and to also articulate strategic directions in line with the stakeholders' feedback.

Regarding our financial viability, a revised, balanced budget was formulated and approved, and from that, two key decisions were made in order to achieve this fiscal balance. First, with deep regret, it was decided to release a salaried employee, that being our Mission Education Coordinator (effective end of November 2017). Secondly, office rental and other associated office costs will be eliminated by co-locating with Emmanuel Care. Although these decisions were primarily motivated by fiscal restraint, we do see the potential benefit to having CHAS, as an autonomous organization, housed under the same roof with Emmanuel Care. We would also like to acknowledge our gratitude to Emmanuel Care for this gracious offer.

Regarding how we will envision our work and contribution to the over-arching ministry of Catholic health

care, and during the course of our re-positioning process, these three key strategic priorities emerged and were affirmed:

- Education and Resources
- Connection to Community
- Advocacy and Communications

Certainly this is a quick summary of the decisions and strategic directions. More robust reporting will be offered at the Annual General Meeting held at 12:30 pm at the DoubleTree by Hilton in Regina on October 21, 2017. Of course we will be happy to answer any questions you may have between now and then.

Again, thank-you for your commitment to the Association, we appreciate all of the support and encouragement from you, our members and stakeholders. As we close in on our 74th year as your Association, we trust that this external financial crisis can be captured as a meaningful opportunity to better align with the needs of you, our members.

We look forward to seeing you all in the fall at the Joint Conference at the DoubleTree by Hilton in Regina from October 20 - 22, 2017. Register soon!

Congratulations to Deutscher on Bioethicist Position

CHAS is very happy to welcome Mary Deutscher, PhD, as the successful candidate to be appointed to

the position of Bioethicist at St. Paul's Hospital (SPH) in Saskatoon. With a start date of May 23, 2017, Mary fills the position left vacant for more than a year after the departure of Joy Mendel in April 2016.

As ethicist, Deutscher will work with and for the faith-based institutional members of the Catholic Health Association of Saskatchewan (CHAS) in urban and rural

Saskatchewan; and in a collaborative partnership with the Saskatoon Regional Healthy Authority, said Jean Morrison, President and CEO of St. Paul's Hospital.

The ethicist works in the context of a Mission Integration team of SPH – which includes leading Catholic health care facilities – in the ongoing development, implementation, evaluation and integration of ethics support services as well as some potential ethics research.

Deutscher received her doctoral degree in Public Policy; her Bachelor of Arts Honours, with High

Honours, in Philosophy; and Bachelor of Science, with great distinction, in Biology from the University of Saskatchewan; and she holds a Master of Arts in Public Ethics from the University of Ottawa.

She recently worked as a Clinical Ethics Fellow for the Centre for Clinical Ethics in Toronto; and presented workshops in various locations among several provinces on "Euthanasia and Assisted Sui-

cide in Canada". Her presentations have also included "Ethics of Human Reproduction" and "Ethical Decision Making in Health Care."

Deutscher brings experiences in clinical and organizational ethics, which she has obtained through her graduate programs, serving as hospital chaplain, her volunteer activities and role on the St. Paul's Hospital Ethics Committee; and the work she completed with the Palliative Care Team at St. Paul's Hospital.

Spiritual Care Funding: cuts made final

In spite of lobbying attempts made by regional and national voices of CASC (Canadian Association of Spiritual Care), along with members of an ad hoc committee comprised of leaders of denominational faith groups, chaplains and other stakeholders (including CHAS), the provincial government was firm in its position that spiritual care funding throughout the province would be cut.


For faith-based health facilities, whose mandate and mission requires that spiritual care be made available, the government acknowledged that their affiliate status allows them to continue the offering of these services, and thusly, spiritual care providers within faith-based facilities will retain their positions. However, this fall, 8 to 10 full-time spiritual care employees posted within various health regions will lose their jobs.

Lobbying efforts amongst denominational leaders and those in faith-based institutions will continue, with the hopes that this core service be reinstated. Your intentions and prayers to this end are greatly appreciated.

Annual Meeting Notice and Call for Resolutions

The 74th Annual Meeting of the Catholic Health Association of Saskatchewan will be held at 12:30 pm on Saturday, October 21, 2017 at the DoubleTree by Hilton Hotel, Regina. Resolutions may be submitted to the Executive Director by a member prior to the Assembly and may also be proposed at the Assembly in accordance with the process established by the Board of Directors. (Bylaw 6.12)

Process for Resolutions:

- Resolutions to be considered for presentation at the Annual Meeting shall be submitted in writing to the Executive Director 21 days prior to the Meeting.
- The Executive Director shall make the Resolutions available to the Executive Committee at least two weeks in advance of the Annual Meeting.
- Resolutions must be accompanied by appropriate supporting documentation.

Resolutions will be received at the CHAS Office up to September 29, 2017.

Resolutions Proposed at the Annual Meeting:

- 1. Resolutions intended to be proposed at the Annual Meeting, shall be submitted in writing with supporting documentation to the President at least 24 hours in advance of the scheduled time for the meeting.
- 2. Resolutions not submitted in accordance with No. 1 will be considered at the Annual Meeting only with the authorization of the President.
