PRESIDENT & EXECUTIVE DIRECTOR REPORT

PRESIDENT & EXECUTIVE DIRECTOR REPORT

July 2019-June 2020

Strangest year ever. Normally, that statement would be considered hyperbole. This year, however, “strange” is just the beginning.

COVID-19 has marked 2020 indelibly. Quarantine, lock downs, protocols changing by the day and by the hour, fear, courage and isolation have changed the character of this past year and it will continue to direct the arc of our mission into the future.

Luckily, in the face of so much legitimate fear and pragmatic worry, our healthcare staff has shown courage and character in their work. More than being heroes in some brief moment, they have shown themselves to be disciples of care, revealing in a very real way what it means to follow Christ into the places he went when he scandalously and courageously approached someone considered in that time to be better kept at a distance (cf. Mark 1:40-45; Matthew 9:9-13; John 8). We continue to marvel at their compassion even in the midst of their own struggles and fatigue.

It is with a spirit of gratitude that we offer you these brief reflections on this past year. **Our major works, including** the annual convention, our visiting campaign, the Compassionate Healers’ Mass, Witness to Mission revamping and the Health Care Guidelines are listed under the [Project Charters Summary](#) later in the Annual Report.

Blake was hired for May 1, 2019 and spent the first few months getting acquainted with the position and organization. In the summer, he visited all the sites and met with some of the staff to ask about some of their priorities. He was planning to arrange another set of visits for the spring when the pandemic took hold and this also quashed attempts at a summer set of visits.

The Governing Council for the Canadian Health Association of Canada has all provincial association EDs present during their meetings. This has been a good opportunity to meet and compare notes with other provincial associations to learn from them and share resources.



October 6-12 is Canada’s first ever National Catholic Health Care Week. CHAC did a very good job of putting together material for individual sites and provinces to use although it may almost be information overload.

People who have been diligently reading CHAS Communiques for some years may have noticed a slightly revised format including larger font size, more and larger pictures and trying to get staff from around the province to submit personal stories, relevant book reviews and resource sharing. We hope that this resource continues to be a source of unifying stories for us all.

Manitoba contacted us about using our version of the Advanced Health Care Directive as the basis for their French translation. They were very grateful for our cooperation.

In October 2019, our ED was invited to witness an honour guard at St. Ann's Home. All available staff and some residents formed a long set of two lines down the hall while a choir sung out the body of a resident who passed in the morning. They were accompanied by the family of the deceased and there were many tears. It is a wonderful ritual that I believe some of the other homes also utilize.



On December 20, Blake was invited to participate in a smudge and feast at St. Paul's. It was a good experience and a good opportunity to talk to a few people about CHAS. I had just done a Johnny Cash sing-a-long at St. Paul's the day before (about 50 people attended) along with Evert Van Olst, previously council for the Saskatchewan Health Authority, and Wayne Salbourn, so I was able to build on some of the relationships I initiated there.

In early January, Blake sent out the World Day of the Sick promotional material to the directors, dioceses, and the spiritual care directors. Some of the bishops sent out letters to their pastors asking them to mark it in their parishes so the word got out broadly. All of the current resources, including Pope Francis' letter is on our website.

CHAS is in conversation with Dr. Gertrude Rompre, Director of Mission at St. Thomas More College, and Francis Maza around the topic of Mission Formation Opportunities with St. Thomas More College and Emmanuel Care. Dr. Rompre is organizing a broader meeting to discuss how our various agencies and work together to maximize the opportunities for people in our province to be better formed for ministry and work with a Catholic perspective.

One insight that has been discussed is that in the early stages of a crisis of the magnitude of the novel Corona virus is that most offers of assistance cannot penetrate the necessary "functional mentality" that an institution enters into. It is the equivalent of offering a cup of tea to a soldier in a firefight; nice thought but not the best timing.

We sent out a letter to all of our sites on Monday, March 16 to thank them for all they do and to offer support in the upcoming months with the pandemic. An offer was made during a shortage of isogel to deliver a supply from Minhaus Breweries but by this time the supply chain was getting back on their feet; it was appreciated. CHAS also reached out to Bolt Mobile and helped a few sites get some free iPhones for their residents to use. My goal is to stay supportive and stay positive.

Dr. Mary Heilman and her husband, Dallas, welcomed their little girl, Aster Cecilia, into the world on March 25, 2020. Congratulations! While CHAS had grown accustomed to having access to Mary's gifts and competence, we have been very blessed to have found Gary Goldsand to cover her maternity leave. He is an impressive candidate and has already found his stride. Welcome, Gary!

Special thanks again goes out to everyone at the Emmanuel Care offices: Scott, Janet, Francis, Loreen, Doug, and recently Karen who have been so welcoming to CHAS. We greatly appreciate your generosity and hospitality in offering CHAS an office!



As many of you know, in early October 2019, one of our board members, Lesley Larrea, was in a very serious car accident. Please continue to remember her in your prayers. We love you, Lesley!

And finally, in terms of our board, all of CHAS offers thanks to our treasurer, Anne Reddekopp, for her years of service to this organization. Coming in as a new Executive Director, it was very reassuring, and on a few occasions incredibly essential, to have Anne asking good questions and offering sage advice. On behalf of the board and all our members, thank you very much Anne! We also thank Terrie for her years of chairing as she steps into the role of past president for one year. Ethna Martin will now take on the role as President and Chair of the CHAS Board. Thank you for stepping up, Ethna!

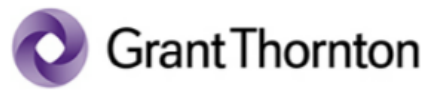
In reference to the Independent Auditors' Report, I would like to note their opinion statement:

"In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Association as at June 30, 2020, and its results of operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations."

The statement of Financial position shows an increase in Assets to \$ 873,305 from the previous year balance of \$ 789,780.

The Statement of Revenue and Expenses shows an Excess of Revenue of \$77, 252 compared to the previous year's adjusted amount of \$52,300. The excess of revenue over expenses for the two years reflects the inclusion of investment income from the restricted funds in the statement of operations. The investment income not available for Operations includes \$12,795 for the year ended June 30, 2020 and \$20,633 for the previous year. Operational Expenses have been reduced this year due to restrictions imposed by Covid -19 which contributed to the surplus.

A special thank you to the CHAS staff and board. I would like to acknowledge their professionalism and dedication to the CHAS mission.

Independent Auditor's Report

To the Members of
Catholic Health Association of Saskatchewan

Opinion

We have audited the financial statements of Catholic Health Association of Saskatchewan, which comprise the statement of financial position as at June 30, 2020, and the statement of operations, statement of changes in net assets and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Association as at June 30, 2020, and its results of operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Association in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter - Restated Comparative Information

Without modifying our opinion, we draw attention to Note 9 to the financial statements, which describes that certain comparative information presented for the year ended June 30, 2019 has been restated. The financial statements for the year ended June 30, 2019 (prior to the adjustments that were applied to restate certain comparative information explained in Note 9) were audited by Cogent CPA LLP who expressed an unmodified opinion on those financial statements on August 23, 2019. The partners and staff of Cogent Chartered Professional Accountants LLP joined Grant Thornton LLP on November 1, 2019.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Association's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Association or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Association's financial reporting process.

Independent Auditor's Report (continued)

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements. As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Association's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Association's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Association to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

Notes to the Financial Statements

Year ended June 30, 2020

1. Purpose of Association

Catholic Health Association of Saskatchewan (the "association") is incorporated under the Saskatchewan Non-Profit Corporations Act on May 27, 1943. The mission of the Association is to offer leadership, education and resources in ethics, mission, spiritual care and social justice. Given its not for-profit status, the Association is not subject to income taxes.

2. Change in accounting policy

Effective July 1, 2019, the Association adopted Section 4433 – Tangible Capital Assets Held by Not for Profit Organizations. Section 4433 replaced Section 4431 Tangible Capital Assets Held by Not for Profit Organizations and requires the application of Part II of the CPA Handbook – ASPE Section 3061 Property, Plant and Equipment and ASPE Section 3110 Asset Retirement Obligations for tangible capital assets held by NPOs, and provides guidance on contributed assets and write-downs of tangible capital assets. As a result of adopting Section 4433 tangible capital assets are written down to fair value or replacement cost to reflect partial impairments when conditions indicate that the assets no longer contribute to an association's ability to provide goods and services, or that the value of future economic benefits or service potential associated with the tangible capital assets are less than their net carrying amounts. This section was adopted prospectively. The Association determined that the adoption of this section had no impact on the June 30, 2020 financial statements.

3. Summary of significant accounting policies

Basis of presentation

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO).

Accounts receivable

Accounts receivable are shown net of allowance for doubtful accounts, if any.

Investments

The association holds a guaranteed investment certificate and a private client managed portfolio corporate class fund that are recorded at fair market value.

The association also holds a mutual fund stated at cost which approximates fair value.

Tangible capital assets

Tangible capital assets are stated at cost or deemed cost less accumulated amortization. Tangible capital assets are amortized over their estimated useful lives on a straight-line basis at the following rates and methods:

Impairment of tangible capital assets

The Association tests tangible capital assets, or groups of tangible capital assets, for impairment whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable. An impairment loss is recognized when the carrying amount of the tangible capital asset or group of tangible capital assets exceeds the asset's fair value or replacement cost.

Revenue recognition

Catholic Health Association of Saskatchewan follows the restricted fund method of accounting for contributions.

Restricted contributions related to general operations are recognized as revenue of the General Fund in the year in which the related expenses are incurred. All other restricted contributions are recognized as revenue of the appropriate restricted fund.

Unrestricted contributions are recognized as revenue of the General Fund in the year received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Restricted contributions for expenses of one or more future periods is deferred and recognized as revenue in the same period as the related expenses are recognized.

Unrestricted contributions are recognized as revenue when received or receivable if the amount can be reasonably estimated and collection is reasonably assured.

Seminar fees are recognized as revenue of the General Fund when the seminars are held.

Fund accounting

The general fund consists of all unrestricted operational activity that is unrelated to the following restricted funds.

The Hon. Emmett M. Hall fund was established for specific education projects in honour of the late Hon. Emmett M. Hall. The fund balance consists of an appropriation of surplus plus specific donations and interest earned on the fund balance less specific expenses.

The Moola Freer Scholarship Fund was established for Palliative Care education and awards by Dr. Dawood and Anne Moola. The fund consists of specific donations and interest earned on the fund balance less specific expenses.

The Ethics Fund was established for the purpose of promoting and providing ethics education, resources and services. The fund was established from the sale of Advance Care Directive booklets and videos, and further enhanced with specific donations. The fund consists of specific donations, income from sales and interest earned on the fund balance less specific expenses.

10. Significant events

Since December 31, 2019, the spread of COVID-19 has severely impacted many local economies around the globe. In many countries, including Canada, businesses are being forced to cease or limit operations for long or indefinite periods of time. Measures taken to contain the spread of the virus, including travel bans, quarantines, social distancing, and closures of non-essential services have triggered significant disruptions to businesses worldwide, resulting in an economic slowdown. Global stock markets have also experienced great volatility and a significant weakening. Governments and central banks have responded with monetary and fiscal interventions to stabilize economic conditions. Impact to the Association may be the cancellation or reduction in annual convention, grants, donations, investments, memberships, and mission formation revenues in fiscal 2021.

The Association has determined that these events are non-adjusting subsequent events. Accordingly, the financial position and results of operations as of and for the year ended June 30, 2020 have not been adjusted to reflect their impact. The duration and impact of the COVID-19 pandemic, as well as the effectiveness of government and central bank responses, remains unclear at this time. It is not possible to reliably estimate the duration and severity of these consequences, as well as their impact on the financial position and results of the Association for future periods.

Project Charters Summary

2019 Annual Convention

The 2019 Convention held in Prince Albert was very well attended and was positively reviewed. The theme of “Mission IS Possible: The Journey of Grace-filled Compassion “. Our presenters offered content relating to how our work is transformed when we make mission the lens through which we make our day-to-day decisions at work.



Two awards were given out at the banquet which was emceed by Brian Martin. The CHAS Mission Award this year went to Roxanne Stringer (left). The Catholic Health Association of Saskatchewan presents an annual Mission Award to honor an individual who has exemplified outstanding service in Catholic Healthcare Ministry in the Province of Saskatchewan.

The Moola Freer Palliative Care Award went to Cliff Geiger (right). Dr. Dawood Moola, who had passed away the summer previously, and his wife Anne established this award and scholarship in 1995 with the aim of furthering the advancement of palliative care education and honoring those who serve with compassion in palliative care.



The convention theme and speakers who were booked for October 22-23, 2020 have been postponed due to COVID for one full year. We have tentatively booked the same hotel in Moose Jaw for October 21-22, 2021.

This year, on October 22 at 10:00 AM via Zoom, we will be hosting a mini-convention with a presentation by a COVID survivor and then an abbreviated AGM. You can register on-line at our website.

Compassionate Healers’ Mass

Liturgies were celebrated in Prince Albert, Saskatoon and Regina as usual but it was held at a regular Sunday Mass in a parish rather than at a separate evening celebration. We will continue to hold these at Sunday liturgies in the future and hope to see more individual parishes celebrate them locally. This year, with the pandemic, the anointing of hands during a procession will be replaced with a more “physical-distance pleasing” verbal blessing.

Visiting Campaign Committee

There seems to be some openness on the part of the dioceses to support a broad campaign aimed at inspiring people to reflect on the important Christian call to care for the sick and lonely (cf. Matthew 25.36; James 1:27; 1 Timothy 5:4), especially in our Catholic healthcare facilities. CHAS has put together a small and gifted committee to discuss and create a visiting campaign that will be shared with the parishes of the province via diocesan meetings in the Fall of 2021. The committee is comprised of representatives from long-term health sites, hospitals, parishes, diocesan offices, rural and urban including Jackie Saretsky, Christine Taylor, Susan Askin, Brian Mee, Cheryl Thul, Loreen Luby, Ethna Martin and Bernadette Heintz. We have high hopes for this effort that aims to address the loneliness and isolation that exists in our society today.

Witness to Mission

The very well-received five-day original model of the Witness To Mission formation retreat was tightened up to a shorter three-day format in the hopes that sites would find that more achievable and affordable. We are also in the early stages of evolving the W2M into a type of formation that can be offered in 60-90 minute segments once or twice a year so that the curriculum is covered over a longer period of time.

This style of formation is valuable for many reasons. This shorter period of professional development is the manner that many care homes and hospitals are used to and it saves the institutions the need to replace staff which was the primary obstacle for many of our partners at this time. This move gives more freedom to the partners to schedule the formation when it works for them and gives them a resource that they can put into a rotation which will allow for the development of a “critical mass” of staff. Finally, this approach enlarges our circles of involvement because the material could potentially be facilitated by a local leader.

The committee includes Brian Zimmer, Leah Perrault, Edgar Neudorf and Lisa Alspach.

Health Care Guidelines

I have reached out to the provincial contacts of Catholic organizations like the Knights of Columbus and the Greater Saskatoon Catholic School Board and prepared a simple letter of offer to come out to either larger meetings or to do teleconferences with smaller council gatherings to share information about the Health Ethics Guidelines. Our aim is to get some councils interested in brief presentations.
