Finding Our Way Through the Pandemic

While on vacation a few years ago, my wife and three kids were driving between Regina and Moose Jaw. I had checked the gas tank before we left and I was sure there was enough gas in the tank to make it to our destination.

I also figured there were plenty of gas stations between these two cities but somehow, about 40 kms outside of Regina, my orange gas light came on warning us that the tank was low on fuel.

My wife and I joked with the kids in the back seat that we should all duck in our seats so as to create better aerodynamics. The kids knew we were joking and they humoured us.

This pandemic originally felt like a short trip. Some of us felt like it would be a few weeks. A few in the know explained that it could be months. Only a few—at least in the early days of March 2020—were planning for up to two years.

Most of us checked our emotional tanks and felt like we could handle a few months but the fourth wave and the Delta variant has challenged even the strongest of us.

Nurses who had signed up for a career in caring are finding it hard to make it through shifts. Care homes that were finally opening

up to visitors are facing challenging decisions about how to move forward prudently.

Meanwhile, across the province, people are shopping without masks, going to music concerts, outdoor festivals, rodeos and even taking in football games at Mosaic Stadium. Many do not want another lockdown.

While we are not out of gas emotionally, our orange light is on.

As an association, CHAS has not been immune. Financial issues from all sides, new Saskatchewan Health Authority restructuring, and pandemic restrictions have meant that much of our mandate was hampered. We could not gather, we could not go to the sites, and much energy had to be put towards daily pandemic safety measures.

We have discerned and surveyed for several months. Our board, along with the help of Brenda Fitzgerald, have come up with a plan to move forward that includes hiring a part-time Executive Director (job ad on back of newsletter), continuing with the convention, newsletters, Witness to Mission video preparation, the parish visiting campaign and the providing of ethics consultations to all institutional members across the province.

We have all struggled but we are all finding our way through this pandemic.
