REPORTS

Presidents Report – Ethna Martin

The year 2021-2022 has been another eventful year for CHAS.

We welcomed our new Executive director, Peter Oliver, to his role in November 2021. I hope that you have all read the E.D. report and know that Peter, the CHAS staff and the board have all been busy working on behalf of the CHAS membership.

We have also welcomed 5 new board members during the year.

Our last in-person CHAS Convention was in 2019.

2020 saw the Covid pandemic outbreak and so we had no CHAS convention that year. In 2021 we held a Zoom convention which in itself was difficult to do as we had no policies or by-laws to guide us. We as a board did the best that we could, under the circumstances, to fulfill the mission of CHAS. There were a few hiccups but hopefully nothing of any great significance.

An in-person meeting is, I think, always the first choice for a convention. Meetings and conventions held by Zoom or some other electronic means do not really allow for networking and social interaction. It is difficult for a board to get to know each other when they only get to see and talk to each other via a screen. The CHAS board has only had one in person event since the pandemic outbreak and that was our retreat which took place in late March 2022. It was a wonderful day when the entire 2021-2022 Chas board met together in person for the first time. We are very blessed to have the great variety of people on the current board who bring with them a wealth of experience and knowledge.

I have been the CHAS board president for the last two years. I have been a member of the CHAS board for the last 6 years and during that time there have been a lot of major changes including the cutting of funds, staff changes and the pandemic.

I leave the board now and I believe CHAS is in very capable hands.

I thank everyone that I have had the privilege to work alongside over the last 6 years. I thank God for each and everyone of you and I know that CHAS, going forward, will weather any other storms that come its way because “The compassion of Christ compels us”.

EXECUTIVE DIRECTOR’S REPORT – Peter Oliver

CHAS is an organization with deep roots in the ministry and sacrifice of what Sister Teresita Kambeitz OSU refers to as “over 7,000 Sister-years of healthcare in the province”. I began working as the ED for The Catholic Health Association of Saskatchewan on November 1, 2021. It is a challenge to lead an

organization with such a rich history. In the last few months, naming important realities has helped me meet this challenge. This report is organized around CHAS' name.

Catholic

Among the priorities I have been able to name in the first several months of my role with CHAS has been the importance of being rooted in the realities that are unfolding as the Catholic Church steps into the future. It is a time of difficult conversations about issues such as residential schools, sexual abuse, the integrity of our faith and the need for a Church that is responsive and inclusive. Establishing a strong working relationship with all the bishops of our province has been a priority. I am grateful and very encouraged that Bishop Stephen Hero has been willing to represent Archbishop Don on our CHAS board. He assisted with leading our Board retreat this year and continues to be an important guide in the work we are doing.

Understanding the Catholic dimension of CHAS in concert with the changing relationship between Emmanuel Health, Emmanuel Care and the new umbrella organization that is being formed between Catholic Health in Alberta and Saskatchewan is important. As well, the important role that the Affiliates Mont St. Joseph in Prince Albert and Villa Pascal in North Battleford play in Catholic Health is a priority.

Our Ethicist, Dr. Mary Heilman's excellent contributions to ethics and Catholic identity are vital to the work CHAS has been doing. While the pandemic was ablaze in the province Mary was still able to achieve a number of in-person presentations and when this was not possible, she offered them virtually. The following offerings were included in her programing: "When is it our Business? Responding to Expression of Sexuality in Long-term Care," "Navigating in a Sea of Change", "Advance Care Planning" and "Am I My Brother's Keeper?". She was also present to numerous ethical consults, staff huddles and prayer events. After returning from maternity leave, Mary rejoined the mission of CHAS with renewed interest and we are delighted by her latest innovation, sharing the Joy Basket.

Health

CHAS' annual convention was identified as a priority in the consultation done by Brenda Fitzgerald in 2021. The conventions of 2020 and 2021 were held virtually and planning for this year's convention started while there was a high degree of uncertainty about the possibility of an in-person gathering. The challenges of the previous years also invited us to carefully consider the tone and direction of the 79th Annual convention. Questions in the forefront of this discernment have been: How is this Convention related to the difficulties healthcare providers have endured in the previous two years? In what way can we include people from our province where there are no Catholic healthcare facilities, especially in the north? How can we take advantage of evolutions in virtual technology so that that convention can be accessed by people who experience barriers imposed by travel, finances, and time? What critically important conversations need to take place at the convention?

These many elements are laying the foundation for CHAS' steps into the future. A future that is firmly rooted in the vision and mission of the sisters who founded the organization 79 years ago.

Association

CHAS is an association and that means we need to have an effective Board of Directors. Since November we have added five very competent members to the board. They bring a deep

commitment to our Catholic faith and expertise in finances. This summer CHAS also activated a Finance Committee which is attending to the challenges faced by past cuts to our budget, stewarding our investments and helping us to chart a course toward future engagements.

How we respond to vulnerable people, especially those in long-term care is a core concern for our membership. For this reason, CHAS was pleased to partner with St. Thomas College and Mont St. Joseph in supporting Dr. Paulette Hunter's research: **Getting Results for Long-term Care Residents, Perspectives from Saskatchewan Healthcare**. Dr. Hunter offers this summary of the project:

Reaching out to "the 39 non-profit facilities that offer specialized long-term care services," the team's goal is to "explore and formally document the challenges organizations delivering specialized long-term care services face". "Tangible results of the project will include presentations and accompanying reports on the relevance of Catholic Social Teaching to non-profit organizations' work, and the goals, achievements, barriers, and dilemmas of healthcare organizations (particularly, specialized long-term care providers who are members of the Catholic Health Association of Saskatchewan and the Provincial Affiliate Resource Group)." "It is also hoped that the dialogue initiated during and beyond the project will" help "inform opportunities to translate the values reflected in Catholic healthcare (e.g., subsidiarity and solidarity) to non-Catholic healthcare partners" and "increased momentum to address the barriers healthcare organizations face in getting results for long-term care residents."

As we move forward, renewing, responding to, and expanding our membership base is a priority. Dialogue with the Bishops of Saskatchewan, the leadership within Catholic Health facilities, the Knights of Columbus, Catholic Women's league and organizers within Indigenous communities is vitally important.

Saskatchewan

CHAS is a provincial organization. Giving thoughtful consideration to this reality is integral to the contribution we can bring to Catholic Health in Saskatchewan. How do we understand "the Saskatchewan" of 2022 and what unfolding realities do we need to attend to in our province? I recently had a conversation with Eric Howe, a professor in the Economics department at the University of Saskatchewan. Eric observes that by 2060 our province will be 50% indigenous. What gifts do these changing demographics bring and what challenges lie ahead? What are some of the social determinants of health that we need to consider and how can we journey together "Synodally" – as Church and community embracing a healthy future?

I'm also conscious that we are a province of the south and the north. The Archdiocese of Keewatin Le Pas stretches across the north of Saskatchewan and Manitoba. It has over 50,000 Catholics, 80% of which are Indigenous and Metis, but no Catholic Health Care facilities. What can be learned about our priorities for Catholic Health Care as we consider the needs of these brothers and sisters.

Finally, we are a province of shifting demographics – increasing urban populations and a significant aging population. It is a population that often experiences challenges in relation to continuity of care. Trust and confidence in the care one receives is closely related to a relationship built over time.

Partnering with the Catholic leadership in our province and supporting a dialogue with other provincial stakeholders needs to inform the way CHAS respond to these challenges.

TREASURER'S REPORT – Joel Rosenberg

I would like to thank all donors and supporters for their contributions which allow us to continue the mission of the Catholic Health Association of Saskatchewan. In collaboration with the membership and leadership, we are pleased to continue providing education and resources in ethics, mission, and spiritual care. We appreciate your commitment to our association.

In reference to the Independent Auditors' Report from KPMG, I would like to note their statement:

“In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Entity as at June 30, 2022 and its results of operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.”

The Balance Sheet shows a decrease to Net Assets from \$845,713 in prior year to a current year balance of \$832,298. This is primarily due to a decrease in the book value of long-term investments from \$776,122 in prior year to a current year balance of \$ 736,898.

The Statement of Operations shows the impact of the long-term investments expense, on a proportional basis, for each of the: General Fund, Hon. Emmett M. Hall Fund, Moola Freer Scholarship Fund, and the Ethics Fund.

There is a deficiency of revenue over expenses of \$13,415 in the current year from an excess of \$71,740 in prior year. The revenue declines due to investment loss of \$34,619 resulted in the move from an excess position to deficiency position in the current year. As in prior years, continued attention to expenditures and general operating expenses are top of mind.

A special thank you to the CHAS staff: Jamie Coulson, our bookkeeper; Mary Heilman, our Ethicist; and Peter Oliver, our Executive Director. I would like to acknowledge their professionalism and dedication to the CHAS mission.

Appendix A

Acknowledgement of an Irregularity - CHAS' AGM of November 16, 2021

The pandemic during 2020 - 2021 actuated a state of emergency throughout Canada and the world. It necessitated numerous government interventions that significantly interrupted or terminated the normal functioning of our communities. A statement from the Chief Public Health Officer of Canada on November 5, 2021 on the Government of Canada website highlights the severity of these circumstances:

Since the start of the pandemic, there have been 1,725,151 cases of COVID-19 and 29,115 deaths reported in Canada. These cumulative numbers tell us about the overall burden of COVID-19 illness to date, while the number of active cases, now at 23,162, and 7-day moving averages indicate current disease activity and severity trends (citation below).

Throughout our community these extreme circumstances necessitated expedient measures to fortify the welfare of almost every organization in our society. Such measures were also required to assure the welfare of the Catholic Health Association of Saskatchewan (CHAS). While acting diligently, with due care and in good faith in fulfilling its mission, the Board acknowledges an irregularity that took place at the AGM of November 16th, 2021. 7.6 of the Association's bi-laws indicates: Provided that a majority of the members of the Board of Directors is present, twenty (20) delegates shall constitute a quorum at an Assembly. No business shall be transacted unless the requisite quorum shall be present at the commencement of such meeting. A virtual AGM was held and a majority of the Board was present, but it was not possible to garner the requisite 20 delegates required by this bi-law.

As evidenced in the meeting minutes, the Audited Financial Statements was accepted, KPMG was reappointed as Auditor for the 2021 - 2022 fiscal year, and four new board members (Cameron Choquette, Shannon Granger, Loreen Rawlyk Luby and Edgar Neudorf) were elected to the board. The Audited Financial Statements was also posted on the CHAS website.
